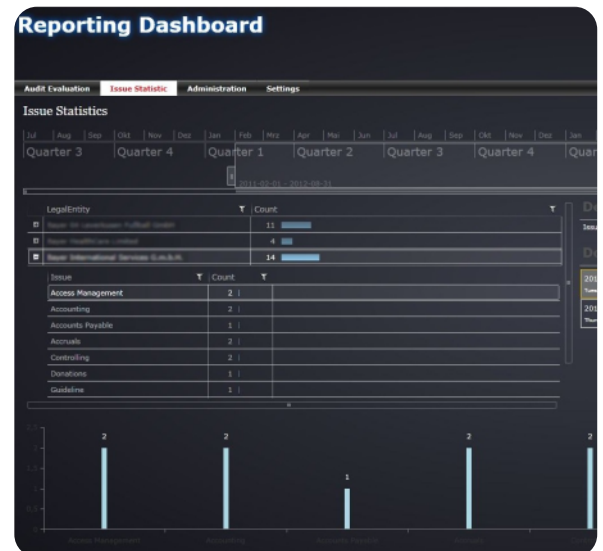
The integration of common Microsoft Office products with all their degrees of
